This past week, the Council voted to approve the updates to the City's \$76 billion budget. I was the [lone vote opposed to passing the budget](#), calling for additional transparency. IDNYC is here! ## Happening in the District

### Traffic Signal Timing at 96th and Broadway

This past Monday, Department of Transportation Manhattan Commissioner Margaret Forgiione joined me for a site visit on the southeast corner of 96th and Broadway. The left-turn light at that intersection turns green about two seconds after the other street lights have turned red, leaving a dangerous moment when pedestrians believe they are able to cross -- since all the street lights are red -- and they place themselves right in front of a lane of cars about to turn left. [I wrote to DOT about this problem last week](#), and I am grateful for their speedy response in this pressing matter. The DOT street engineer agreed to change the signal timing and will complete that work within a month (several of the lights need to be rewired).

On **Monday, January 26** the Department of Homeless Services (DHS) will conduct its annual Homeless Outreach Population Estimate (HOPE) Count, and they need your help!
